- 2. Student must be NO Younger than 15 and 9months by the first day of class and will provide a copy of birth certificate in proof of this. Student agrees to attend all scheduled classes.
- 3. Please be prompt to classes. Students are not allowed to miss more than a total of 4 hours of class for any reason. ALSO, FOR THOSE FOUR HOURS YOU WILL NEED A NOTE STATING SICKNESS, INJURY, OR FUNERAL IF NOT IT WILL RESULT IN AN INCOMPLETION OR FAILING GRADE FOR THIS COURSE.
