- 2. Student must be NO Younger than 15 and 9 months by the first day of class and will provide a copy of birth certificate in proof of this. Students agree to attend all scheduled classes.
- 3. Please be prompt to classes. Students are not allowed to miss more than a total of 4 hours of class for any reason.
